## Theme - Supreme Court Ruling on Provident Fund applicability on allowances -Its implications and Impact on Industry

EPF has made laudable strides with e-governance, but there are many issues and challenges in provident fund administration. The recent Supreme Court judgment on wage components for PF computation has some implications in order to ensure compliances. Supreme Court has ruled out that the allowances in question were essentially a part of the basic wage camouflaged as part of an allowance so as to avoid deduction and contribution accordingly to the provident fund account of the employees. Essentially, it means that the PF contribution will be on the total amount including all the allowances paid to an employee and not just on the basic salary. The session is crafted in a manner to understand the Supreme Court judgement on PF contribution; how it impacts your PF and take-home pay and it implications.
